Dear Tom and Ray:

I am having a debate with co-workers about whether filling your gas tank halfway is more or less efficient than filling your gas tank completely. What is the most efficient way to fill a tank? Does the weight of a full tank affect the mileage? Does gas evaporate more quickly when the tank is halffull? I need your help to decide this debate and to decide the most efficient way to fill a gas tank. Thank you! — Ian

RAY: I take it you're worried about the weight of the gasoline, Ian. You think that a full tank of gas weighs more, and therefore reduces your mileage. And by filling up only halfway, you'll have a lighter car and get more miles per gallon.

TOM: The answer is, that's true. I mean, sure, theoretically, if your 3,000-pound car is 50 or 60 pounds lighter, you'll get slightly better mileage. In fact, manufacturers spend all kinds of money taking ounces of weight out of various car parts.

RAY: Right. And there's no fuel lost to evaporation, because the fuel system in a modern car is a closed system.

Mayor who brought gambling to Atlantic City dead at 84

ATLANTIC CITY, N.J. (AP)

Joseph Lazarow, a recordbreaking glad-hander who presided as mayor of Atlantic City during the dawn of the casino industry, has died in St. Petersburg, Fla. He was 84.

The low-key attorney and Atlantic City native known for his integrity and for his publicity stunts died Thursday after a long illness, said his daughter. Robin Lazarow. She declined to identify the illness.

With little political experience, Joseph Lazarow was elected to the City Commission - now the City Council - in 1972. His counterparts on the council named him mayor in 1976, the start of the aging beach town's transformation to

a glittery, gambling mecca.

The first casino opened in 1978 after Lazarow was named chairman of the Committee to Rebuild Atlantic City, which supported a ballot measure to open casinos as an urban redevelopment tool.

On the committee and as mayor, the soft-spoken Lazarow argued to no avail for a rule that casinos hire only Atlantic City residents, angering nearby communities. He also opposed casinos along the famous Boardwalk, contending they would displace residents and the new businesses would best fit on the outskirts of town.

In July 1977, Lazarow bested a world record set by Teddy Roosevelt in 1901 for shaking hands in a single day. Lazarow did it 8,514 times, beating Roosevelt's record of 8,513, according to the Guinness Book of World Records.

After Lazarow set the record by one shake on the Boardwalk. he got into a motorcycle sidecar and drove throughout the city to shake still more hands. Before quitting that night, he reportedly had shaken more than 11,000 hands.

Lazarow served as mayor until 1982. He remained in the city until the death of his wife, But he was best known for Fredlyn, in 1993, moving to

Bert Bolin, leader of U.N. climate panel, dies at 82

Bert Bolin, a pioneering climatologist and the first chairman of the U.N. Intergovernmental Panel on Climate Change, which shared the 2007 Nobel Peace Prize with former Vice President Al Gore for their warnings about global warming, died Sunday in Stockholm. He was 82.

The cause was stomach cancer, Henning Rodhe, a chemistry professor and colleague of Bolin at Stockholm University,

told Agence France-Presse. Rodhe said Bolin "was thrilled" that the U.N. panel had shared the Nobel Peace Prize. "He was supposed to have gone to Oslo to accept the prize, but was too sick," Rodhe said.

Last month, Gore wrote to Bolin: "Bert, you set up the framework for the IPCC and without your contributions we would not have come to where we are today. Thank you for starting the process.'
