





Pool that inspired 'Pride' closed

PHILADELPHIA (AP) — The pool that helped inspire a movie about an inner-city swim team and its dedicated coach has been closed indefinitely because of serious disrepair.

Marcus Foster Pool was where aquatics coach Jim Ellis — played by actor Terrence Howard in the 2007 film "Pride" — turned hundreds of Philadelphia children into competitive swimmers.

But the city school district, which owns the 28-year-old pool, closed the facility last week, citing concerns about its deterioration.

The move infuriated Ellis, who said the district created situation by failing to properly maintain the pool for years.

"I know swimming pools are expensive to maintain, but in a city the size of Philadelphia, you can't complain you need programs to get kids off the street and then ignore a program that for 30 years has been extremely successful in doing that," said Ellis, an employee of the city recreation department.

The Foster pool and three others are closed because they need "millions of dollars" worth of repairs and improvements, district spokesman Vincent Thompson said.

"We don't want to deny anyone the opportunity to use any of our facilities for sports and recreation," Thompson said. "But the School District of Philadelphia has precious (few) resources in our budget, and the core of our mission is to educate children."

Administrators plan to discuss the problem with city officials with an eye on "shared resources," Thompson said.

Since "Pride" came out, Ellis has toured the country as a motivational speaker. He also continues to coach, but said his competitive program — which once had about 300 kids — is down to just 20.

As Foster pool fell into disrepair, Ellis said, fewer kids wanted to swim there. The program now practices at nearby La Salle University.



Cardinal who led campaign against abortion dies

VATICAN CITY (AP) - Car- sure legalizing abortion in the dinal Alfonso Lopez Trujillo, a capital during the first 12 weeks Colombian prelate who helped lead the Vatican's campaign against abortion and insisted condoms do not prevent HIV transmission, has died, one of his assistants said Sunday. He was 72.

Lopez Trujillo died Saturday night at the Pius XI private clinic in Rome, where he had been admitted for tests on March 17, Monsignor Jorge Raigosa said.

He died after suffering cardiac arrest following medical complications over several weeks that had put the cardinal in intensive care at times, said Raigosa, who declined to elabo-

Vatican Radio said the cardinal had been hospitalized for 'grave health problems.'

In March 2007, Lopez Trujillo traveled to Mexico to launch the Roman Catholic Church's aggressive campaign against plans in the predominantly Catholic country to legalize abortion. Catholic teaching forbids abortion as a grave sin.

The cardinal inaugurated an international anti-abortion conference in Mexico City by celebrating Mass in the Basilica of the Virgin of Guadalupe, the most important Catholic shrine in the Americas.




