Foster care could be wrenching for Texas polygamist sect children

SAN ANGELO, Texas -Many of the children have seen little or no television. They have been home-schooled essentially all their lives. Most were raised on garden-grown vegetables and twice-daily prayers with family. They frolic in long dresses and buttoned-up shirts from another century. They are unfailingly polite.

The 437 children taken from a polygamist compound in West Texas are being scattered to group homes and boys' and girls' ranches across the state. plunged into a culture radically different from the community where they and their families shunned the outside world as a hostile, contaminating influence on their godly way of life.

The state Child Protective Services program said it chose foster homes where the youngsters can be kept apart from other children for now.

"We recognize it's critical that these children not be exposed to mainstream culture too quickly or other things that would hinder their success,' agency spokeswoman Shari Pulliam said. "We just want to protect them from abuse and neglect. We're not trying to change them.'

The children were swept up in a raid earlier this month on the Yearning for Zion Ranch run by the Fundamentalist Church of Jesus Christ of Latter Day Saints, a renegade Mormon splinter group that believes in marrying off underage girls to older men. State child-welfare authorities said there was evidence of physical and sexual abuse at the ranch.

The youngsters are being moved out of the crowded San Angelo Coliseum and will be placed in 16 temporary facilities around Texas - some as far away as Houston, 500 miles until individual custody hearings can be held.

Those hearings could result in a number of possibilities: Some children could be placed in permanent foster care; some parents who have left the sect may win custody; some youngsters may be allowed to return to the ranch in Eldorado; and some may turn 18 before the

Several attorneys for FLDS children called Wednesday for custody cases to be spread out among family law courts across Texas - venue changes that, they acknowledged, would likely require authorization from the Texas Supreme Court.

"It's one court that's bogged down with 437 children. There is no possible way that my client's needs ... can be addressed in a timely fashion," attorney Laura Shockley at a Dallas news conference.

"These children who have lived in a very insular culture and are suddenly thrust into mainstream culture. There's going to be problems," said Susan Hays, who represents a toddler in the custody case. "They are a throwback to the 19th century in how they dress and how they behave."

Ken Driggs, an Atlanta lawyer has long studied and written about the FLDS, said that if kept away from their parents' culture long enough, the children may begin to emulate those around them.

Pulliam said the temporary foster care facilities have been briefed on the children's needs. "We're not going to have them in tank tops and shorts," she to."

Authorities will try to obtain the youngsters' traditional clothing from their parents, and also arrange for visits from some of the adults, state attorney Gary Banks said.

In addition, CPS has sent instructions to the foster homes to feed the youngsters fresh fruits and vegetables, chicken, rice and other foods that may have been grown on the 1,700acre ranch.

"They don't eat a lot of processed food, and we're not going to encourage that," Pulliam said, but noted that if the children want to eat processed or junk food, no one is going to stop them.

Congress close on bill to ban genetic discrimination

WASHINGTON (AP) - Law- bill makers have agreed to make it illegal for employers and insurance companies to deny applicants jobs and health-care coverage because DNA tests show they are genetically disposed to a disease

Supporters of the Genetic Information Nondiscrimination Act said Wednesday that the Senate planned to vote on it today. The House also is likely to give quick approval to the bill, sending it to President Bush for his signature.

A similar bill passed the House by a 420-3 vote a year ago. The White House, at the time, indicated its support for the legislation.

Sponsors reached an agreement Tuesday with Sen. Tom Coburn, R-Okla., who had been blocking Senate action on the

The compromise tightens language to ensure there is a "firewall" between the part dealing with health plans and the section regarding employment so as to discourage inappropriate claims.

It also makes clear that, while individuals are protected from discrimination based on genetic predisposition, insurance companies still have the right to base coverage and pricing on the actual presence of a disease.

Sens. Olympia Snowe, R-Maine, Edward Kennedy, D-Mass., and Mike Enzi, R-Wyo., and Rep. Louise M. Slaughter, D-N.Y., have been pushing the issue for years, asserting that dramatic advances in genetic research make it crucial that people are protected from discrimination.

Atlantic City to ban smoking on floor of casinos

ATLANTIC CITY, N.J. Gamblers on the floors of Atlantic City casinos will soon have to give up at least one vice: smoking.

Ending a battle that lasted more than a year, the City Council voted 9-0 Wednesday to end the last major loophole to a tough statewide ban on smoking in public buildings that had conspicuously exempted gambling halls.

But patrons still will be able to light up in unstaffed smoking lounges away from the table games and slot machines if the 11 individual casinos choose to build them. The ban takes effect Oct. 15.

Casino workers - many wearing T-shirts with the slogan "Nobody deserves to work in an ashtray" - burst into applause when the votes were counted and chanted, "Thank you, thank you, thank you."

"The employees of Atlantic City's casinos have hit a jackpot of their own tonight,' said Dr. Arnold M. Baskies. chief medical officer for the American Cancer Society in New Jersey and New York. "Hardworking casino employees have been keeping Atlantic City's multibillion-dollar casino industry on a roll but have been gambling with their lives for far too long.

Marybeth Litchholt, a dealer for 21 years at Trump Plaza Hotel and Casino, said it's about time that casino workers' health is as valued as those of other workers in New Jersey.

"Because of cigarette smoke, I have sinus problems," she said. "There are times when I'm working in the smoking section when I'm short of breath. You can just

feel it in your lungs. My clothes stink."

More than two dozen states nationwide regulate smoking inside casinos, eight ban smoking altogether inside the gambling halls and two others will impose a total ban starting in 2009, according to Karen Blumenfeld, policy director of the New Jersey Group Against Smoking Pollution.

In January 2007, Atlantic City tried to pass its own law banning smoking in the casinos but backed down under withering pressure from the casino industry, which claimed the measure could cut revenue by 20 percent and mean the loss of as many as 3,400 jobs. The City Council then enacted a compromise law restricting smoking to no more than 25 percent of the casino floor.

But that hasn't worked. The smoking areas are still not walled off and separated from nonsmoking areas, as last

year's law had called for, and smoke still wafts throughout the casino floor. Smokers still feel persecuted, and casinos still fret about losing business in an already bad economic climate, which is being worsened by the growing success of slots parlors in nearby Pennsylvania and New York.

Kim Hoverman, a smoker from Stone Creek in Cumberland County, said she plans to take her business elsewhere.

"I don't think there should be separate areas," she said as she played a slot machine and puffed on a cigarette at the Trump Taj Mahal Casino Resort. "I won't come here at all; I live closer to Philadelphia, anyway. And I hate smoking outside.'

Tom McGuigan of Philadelphia also was sampling the slots at the Taj Mahal. But he, too, will stick to slots parlors in his hometown once Atlantic City's smoking ban takes effect in October.

"I like to smoke," he said. "I'll do it in Philadelphia."

But Kim Hesse, a Caesars dealer and smoking opponent, predicts people like McGuigan will be the minority.

There are lots more nonsmokers than smokers," she said. "I see it every day at my table; I'd say it's about 80-20 in favor of nonsmokers.'


