# Louise Steinman Ansberry

Louise Steinman Ansberry, 85, of Lancaster, passed away



on Thursday, March 13, 2008, at her home in School Lane Hills. Known to many as Tinnie, she was the eldest daughter

James Hale and Louise Tinsley Steinman.

Mrs. Ansberry was born in Baltimore, MD in 1922 and attended the Shippen School in Lancaster before matriculating at the Greenwood School in Ruxton, Maryland, from which she graduated in 1940. She also attended Finch Junior College and the Katherine Gibbs Secretarial School in New York.

After leaving school, Mrs. Ansberry took a job as a secretary at CBS in New York, but left shortly thereafter for Washington, D.C., where she developed a life-long interest in politics. She served on Capitol Hill, working for Reps. George Rhodes (D-Pa.), Stuart Symington (D-Mo.), and Sen. James Duff (R-Pa.). She also served on the finance committees for Dwight Eisenhower and Richard Nixon, and of Robert Kennedy's senatorial campaign. From 1947 until 1971 she was Washington correspondent for the Lancaster Sunday

While living in Washington, she was a legend on the scene at which Washington's political and social worlds intersected. In a front page Style Section article in the Washington Post on February 17, 1975, she explained that she always tried to ask people to dinner who had opposing viewpoints. That often led to interesting conversations and, occasionally, skirmishes, like the celebrated confrontation between columnist Drew Pearson and Sen. Joe McCarthy (R-Wisc.) at a Sulgrave Club dinner she hosted. Sen. McCarthy called Pearson "an unprincipled liar" and "a Moscow-directed character assassin" before she diffused

ator, "You are such an old fool,

Mrs. Ansberry's interest in Indonesian culture and music culminated in her acquisition of a Royal Court Gamelan from Solo, Central Java. In 1983 she donated the gamelan, a full 50piece orchestra, to Wesleyan University, where it has assumed an integral role in Weslevan's Ethnomusicology Program.

From the mid 1970s through 1981, Mrs. Ansberry spent parts of each year at her residences in Tugu, West Java, Indonesia, Ubud, Bali, Indonesia, New York City, Washington, DC and Berkeley, CA.

Mrs. Ansberry's marriages to T. Peter Ansberry and Subur Rahardja ended in divorce.

# Cocaine effects can mimic heart attack

New guidelines instruct

emergency room doctors to

be aware that symptoms of

a heart attack in younger

patients with no heart

disease risk factors may

be caused by cocaine use.

DALLAS - Younger ER patients with heart attack symptoms should be asked if they've recently used cocaine, which can cause similar chest pain, the American Heart Association warns doctors.

For these patients, honesty can be a matter of life or death: Some heart attack treatments can be deadly to someone using cocaine.

New guidelines published online Monday in the American Heart Association journal Circulation say that emergency room doctors need to be aware that symptoms of a heart attack in younger patients with no heart disease risk factors may be caused by cocaine use.

The drug can cause chest pain, shortness of breath, anxiety, palpitations, dizziness, nausea and heavy sweating - all symptoms of a heart attack.

"Not knowing what you are dealing with and giving the wrong therapies could mean death rather than benefit," said Dr. James Reiffel, professor of clinical medicine at Columbia University Medical Center/ New York Presbyterian Hos-

tack," said James McCord, who chaired the statementwriting committee.

Two typical heart attack treatments can be dangerous to those using cocaine:

 Clot-busting drugs carry it's important for anyone with an extra risk of bleeding into the brain in patients whose blood pressure is high due to cocaine use.

 Betablockers that can lower blood pressure without director of the chest pain unit constricting arteries in typical

opposite effect in cocaine users, raising blood pressure and squeezing cocaine-narrowed arteries.

Reiffel said doctors should explain why it's important to know if a patient is using cocaine. He said that admitting use of an illegal substance is confidential information that won't be reported to law enforcement. "The caregiver is not here to judge."

The statement also recommends that cocaine users who do have a coronary artery blockage get a bare metal stent instead of a drug-coated one since chronic drug users may not reliably take the medication needed to prevent new blockages.

McCord said that the drug counseling available in observation units varies among hospitals, and that more could to improve the counseling cocaine-using patients get.

"I think an ideal scenario would be someone whose job is to talk to them about this - explain the extent of the health problems, give them information about resources to help them quit cocaine," McCord
