

SPECIFIC PRIVACY STATEMENT ON PERSONAL DATA PROTECTION

Survey on the satisfaction with the Global AMR R&D Hub's Dynamic Dashboard

1. OBJECTIVE

The objective of this survey is to assess users' satisfaction with the Global AMR R&D Hub's Dynamic Dashboard, including its user-friendliness, content, and other aspects relevant to the use of the Dynamic Dashboard.

2. WHAT PERSONAL INFORMATION DO WE COLLECT AND THROUGH WHICH

TECHNICAL MEANS? Technical information

Your reply and personal data will be collected through a survey link. This survey is launched by an external company PPMI Group (= the Processor).

Respondents may choose to participate in the survey via the survey link which will be available in the Dynamic Dashboard and distributed via other communication channels of the Global AMR R&D Hub. The questionnaire is available in the English language. The results of the survey will be analysed in the reports of the External evaluation to monitor progress towards the objectives of the Global AMR R&D Hub.

All responses to the survey questions and personal data will be collected using an online survey tool SurveyGizmo. This tool allows the subscribed organisations to create their own surveys and collect data from respondents. The system is 100% web-based and completely secure. All survey responses collected through SurveyGizmo are secured and encrypted SSL (Secure Sockets Layer). As a result, they ensure the same level of security as online banks.

The servers, on which SurveyGizmo EU branch operates, are based in Frankfurt, Germany. Therefore, all collected data will be stored at the data centre in Frankfurt, Germany, and will not be transferred to any other locations. Any personal information and data collected, used and disclosed in the course of using SurveyGizmo will be treated in the manner set out in the Privacy Statement of SurveyGizmo.

By proceeding with the survey, you indicate your acceptance of this Privacy Policy and consent to the following:

- You consent to the collection, use, disclosure and processing of your personal data in the manner described in the Privacy Policy, including the procedures relating to cookies, IP addresses and log files;
- You consent to sharing your personal data with relevant persons working for service providers who assist SurveyGizmo in provision of their services;

The Statistical Package for Social Sciences (SPSS) or Software for Statistics and Data Science (Stata), and Excel software will be employed to analyse and visualise the collected data. Analysis will be carried out by PPMI Group.

3. WHO HAS ACCESS TO YOUR INFORMATION AND TO WHOM IS IT DISCLOSED?

The access to all personal data as well as all information collected in the context of this evaluation is only granted through UserId/Password to a defined population of users, without prejudice to a possible transmission to the bodies in charge of a monitoring or inspection task in accordance with Community legislation. These users are the members of the research team within PPMI Group. Anonymised and aggregated data will be used in the study report. Data processing by PPMI shall be carried out in accordance to the PPMI Group Privacy Policy.

No personal data is transmitted to parties which are outside the recipients.

4. HOW DO WE PROTECT AND SAFEGUARD YOUR INFORMATION?

The collected personal data and all information related to the above mentioned consultation is stored on a computer of the the Processor, who has to guarantee the data protection and confidentiality required by the Regulation (EU) 2018/1725.
