He was a recognized leader in the areas of curriculum development and he spoke at local high schools throughout the area on the wonder and magic of literature. Dr. Centola brought his sharply focused insights on literature and higher education to community and professional audiences alike, most recently during his interviews on National Public Radio and "Creatively Speaking" for WRTI, Temple Public Radio. He regularly participated in talk-back sessions surrounding performances of Arthur Miller's plays including one in Delaware for the opening of Mr. Miller's last play, The Price in 2005. In 2003, he appeared on the PBS series "American Masters" in the "None Without Sin"

Thomas Centola of Woodlyn. Dr. Centola began his career in 1981 as an Assistant Professor of English at Virginia Tech. He earned his B.S. in English from West Chester University of Pennsylvania in 1974; these were followed by an M.A. in English and American Literature from the University of Rhode Island in 1977 and a Ph.D. from the University of Rhode Island in 1982.

In 1985, Dr. Centola joined the English Department at Millersville University as an Assistant Professor with duties in the teaching of American literature and writing studies. Dr. Centola designed and taught a range of courses in American drama, the American novel, American regional literatures, and seminars on the works of Arthur Miller, F. Scott Fitzgerald, Ernest Hemingway, and Eugene O'Neill. All of his courses were extremely sought after, very popular and widely influential. He directed or served as a reader on many graduate and undergraduate thesis projects.

Dr. Centola was the author of numerous published articles on Arthur Miller in scholarly journals, essays in refereed collections, and numerous books including an edition of Arthur Miller's collected essays,

documentary. Dr. Centola was a passionate and dedicated teacher who will be sorely missed by all those who knew him. He was widely revered for his vision, his versatility in combining the study of literature with other disciplines, and his flexibility of

mind. In his 26 years as a college professor, he showed exceptional dedication to student learning, encouraging students and recognizing their potential, and he exemplified the liberal arts tradition in higher education.

Steve was active member of St. Leo The Great Church and in many facets of his community. His love of sports led him to coaching, an experience he treasured. Throughout the years he served as a coach for the Hempfield Travel Soccer Team, and Lanco United Premier Soccer Team, as well as head coach of the Lancaster Catholic High School girl's soccer team. He also helped as an assistant coach with the Lancaster Catholic boy's soccer team. Most recently, Steve coached his son Devon's basketball team at St. Leo the Great School.

# '07 a real downer for AC casinos

ATLANTIC CITY, N.J. (AP) A punch in the mouth. A kick in the pants. A slap in the face.

Call it what you like, but 2007 was a painful wake-up call for Atlantic City, the gambling resort which for 28 previous years had known nothing but ever-increasing revenues.

Year-end figures released Thursday by the state Casino Control Commission document the first-ever decline since casino gambling began here in 1978, showing a 5.7 percent decrease from the previous year.

All told, the city's 11 gambling houses took in \$4.92 billion, down from \$5.21 billion in 2006. Only three casinos reported increases for the year.

Most of the damage was done by the opening of slots parlors in Pennsylvania and New York, which drew customers who were once Atlantic City's exclusive domain. A partial smoking ban didn't help, cither.

Slots revenue fell 8.9 percent in 2007, even as table games revenue was up 3 percent.

"It was difficult, no doubt about it," said Mark Juliano, chief executive officer of Trump Entertainment Resorts, which operates three of the city's 11 casinos. "The real impact of '07 was plain and simple: It was Pennsylvania. It's also not going anywhere.

"The good news is it has reinforced with all the major players here the need to work really hard to transform Atlantic City to the next plateau, a place where people come and stay for two or three days instead of relying on day-tripping bus customers."

## Boy, 15, to be charged in **Berks school stabbings**

READING (AP) - A 13year-old boy will face aggravated assault and other charges after he allegedly stabbed three students and brought explosives to school, police said Thursday.

The boy is due in juvenile court for a detention hearing Friday, Central Berks Regional Police Sgt. Ronald Uczynski said

The eighth-grader, whose name has not been released by authorities, is being held at the Berks County Juvenile Detention Center.

Witnesses said the boy, wearing a dark trench coat and listening to his MP3 player, burst into an English class Wednesday and began slashing at students with a knife, flipping desks, throwing books and lighting firecrackers.

Three students suffered minor stab wounds; fellow stu-

dents intervened to stop the attacks before the boy was subdued by school officials at Antietam Middle-Senior High School.

Police said the boy brought to school a small can of gasoline, a water bottle filled with torch fluid, firecrackers, knives and face masks to keep out fumes.

When the school reopened Thursday, students could use only one entrance to get inside and police searched every student with a handheld metal detector.

Police Officer Ray Serafin said all bags were searched and some pocketknives and other minor contraband were seized.

The school in Lower Alsace Township, about 60 miles northwest of Philadelphia, enrolls 540 students in grades seven through 12.

Yet the reasons they come to Atlantic City are some of the very ones casino executives trumpet as things that make Atlantic City an appealing alternative to racetrack slots parlors in other states.

"We love the Boardwalk, the water and the scenery," said Ann Cappielli, who comes here once a month and who was hoping to win back the \$60 she had just lost on slots at the Tropicana.

"I love the restaurants and the shops, and just sitting on the Boardwalk and watching people from all walks of life go by," added her friend Madeline Franco. "You can't do that at Mohegan Sun. You're trapped inside the casino there.

Yet the Atlantic City that these three women know is changing.

The revenue decline has meant cutbacks on free rooms, show tickets and even buffet coupons mailed to gamblers to get them to come here. And along with a wave of new hotel tower construction that will add more than 2,500 rooms to the market by Labor Day will come top-name - and high-priced - entertainment and dining venues.

In December, the casinos' revenue fell by 10.6 percent, led by another awful month at the Tropicana, whose owners lost their casino license that month after a year of poor performance.

The Tropicana was down 20.9 percent in December, and 12.1 percent for the year. About two dozen potential buyers have expressed interest in the Tropicana, which is expected to be sold by the end of April.

Caesars Atlantic City was the only casino that had what could be considered a good year in 2007, with its revenue up by 5.1 percent. Harrah's Atlantic City showed a 2.1 percent increase, and the Borgata Hotel Casino & Spa, which routinely dominates the market here, showed an increase of just 1.6 percent for the year. The Borgata, however, led all casinos with revenue of \$750.9 million.

# Hollywood's 'Mayor' Johnny Grant, 84

LOS ANGELES (AP) -Johnny Grant, the avuncular honorary mayor of Hollywood who traveled the world as Tinseltown's No. 1 cheerleader for more than a half-century, has died. He was 84.

Grant died just before 7 Wednesday, apparently p.m. of natural causes, said Officer Jason Lee. Grant was found dead on a bed in the Hollywood Roosevelt Hotel, Lee said.

Grant was perhaps best known as the jolly host alongside more than 500 celebrities he inducted into the Hollywood Walk of Fame.

The lifelong bachelor lived in a 14th-floor suite at the Hollywood Roosevelt Hotel.

Grant's mission in life was in bit parts in movies, and produced Hollywood's annual Christmas Parade.

"I feel I have been the luckiest guy in the world," he often said. "It's been a pretty good ride."

Ana Martinez-Holler, a spokeswoman for the Hollywood Chamber of Commerce who has worked with Grant for 20 years, said he had had several recent health problems, including a broken bone in his back.

"I had lunch with him today . we had omelets together, and he said he wasn't feeling good," she said Wednesday. "I saw him walk away after lunch, and that was the last time I saw him."

"Hollywood won't be the same without him," she said.

Grant also joined globe-trotting Bob Hope as a USO ambassador, bringing entertainers to war zones to perform for U.S. military personnel during the Korean and Vietnam wars and battles in the Middle East.

He helped introduce home-

sick soldiers to Debbie Reynolds, Connie Stevens, Jane Russell, Terry Moore, Penny Singleton and Angie Dickinson, among others, leading Hope to once quip that he himself was 'the rich man's Johnny Grant.'

"You'll never find a more generous soul in your life. Dickinson told The Associated Press in 2006. "He was a ladics man. He's a Taurus. He's a doll."

Another close friend, actress Mamie Van Doren, described Grant simply as "Mr. Hollywood."

"I dated him in my teens," she recalled. "He's one of the greatest people I've ever known, so kind."

Over the years, Grant chatted with Marilyn Monroe, Elizabeth Taylor, Michael Jackson, Tom Cruise, Bing Crosby, Walt Disney, Frank Sinatra and Dolly Parton and was a friend to several presidents, including John F. Kennedy, Lyndon B. Johnson and Richard Nixon. Hc counted President Reagan as one of his closest friends.

Born in Goldsboro, N.C. Grant was a cub reporter for radio station WGBR when he hitchhiked to Washington to cover President Franklin D. Roosevelt's third inauguration. The diminutive reporter sat in a tree to write down what he saw for his report.
