He graduated from Penn State University in 1936. He took one year of graduate studies in art at Harvard and further work at Penn State and the University of Pennsylvania. He supervised the art program at Avon Grove Consolidated Schools in West Grove, PA, and then taught art at Fort Hill High School in Cumberland. MD. He began his employment with Penn State University in 1942 as an instructor in fine arts at the Pottsville campus. In 1945 he served as the field director with the American Red Cross at Pearl Harbor. Upon returning, he was named assistant administrative head of the Pottsville Campus. In 1948 he was asked to establish a new Penn State campus on a 400acre estate near Erie. He founded and directed until 1954 what has become Penn State-Erie. In 1954 he went to University Park as Director of the University Adult Conference Center. In 1958 he became Director of University Relations and in 1969 was promoted to Vice President for Public Affairs with responsibility for federal, state, community and alumni relations and the Office of Public Information. He retired from Penn State in 1975 with citations from the Penn State Board of Trustees, the Pennsylvania State House of Representatives and the Governor of Pennsylvania.

In 1988 Penn State-Erie gave Ferguson its Medal of Honor and later created a student award in his name. The same year, he was named an Outstanding Alumnus of the College of Education. In 2003 Penn State named one of the West Campus Housing Complex buildings T. Reed Ferguson, Jr. Hall in recognition of his years of dedicated service to Penn State as Vice President for Public Relations.

He served on the State Col-

merce Board of Directors for nine years and was president in 1967-68. The Chamber later awarded him a Life membership plaque. He served on the vestry of St. Andrews Episcopal Church and was on the Board of Directors of the Friends of the Museum at Penn

After his retirement, he took a one year position with Supelco of Bellefonte, living in Switzerland to start a branch of the business there. After eight years of travel, he and his wife moved to St. Simon's Island, Georgia. He was active there with the Coastal Museum, serving on the Board of Directors and curating an exhibit on cotton planters and plantations on the Sea Islands. From that research, he wrote a biography, The John Couper Family at Canon's Point published in 1994 by Mercer University Press. In 1996 he edited and annotated The 1836 London Diary of James Stratton Carpenter, MD published by Minerva Press of

Court gives U.S. access to land for border fence

WASHINGTON (AP) Leaders in a small Texas border city felt blindsided Wednesday after learning that a judge had ordered public land turned over temporarily to the federal government as it works on a border fence.

U.S. District Judge Alia Moses Ludlum ordered the city of Eagle Pass to "surrender" the 233 acres of city-owned land by Tuesday. The Justice Department had sued for access to the land on Monday. Ludlum's ruling came the same day, before the city could muster a chal-

The Homeland Security Department is trying to build 370 miles of border fence by the end of the year. A law signed by President Bush and supported by both of Texas' U.S. senators mandated a total of 700 miles of fence along the border. The ties.

government had warned the city, which opposes the fence, that it would sue under eminent domain laws to secure access to the property.

The judge's order, issued in the Texas Western District Court, Del Rio division, said the United States, the plaintiff, is entitled to possession or control of the property for 180

"Well, that seems a little heavy handed," Eagle Pass Chad Foster said Mayor Wednesday.

Foster leads the Texas Border Coalition, a group of border mayors, city officials and business leaders who oppose Homeland Security's border fence plans and have complained that they haven't had enough input on the effects of the fence on their communi-

PORTLAND, Ore. (AP) — Mental patients at the Oregon State Hospital, the setting for "One Flew Over the Cuckoo's Nest," were exposed to threats ranging from infectious outbreaks to patient-on-patient assaults, according to a Justice Department report released Wednesday.

The report, based on an investigation in 2006, found Oregon's primary adult psyincluding multiple suicide attempts, while under staff observation.
