George T. Stradling, Jr., 91, formerly of Akron, entered into rest at Ephrata Manor, on March 20, 2008, where he had been a resident since 1996.



Born in Honey Brook, PA, on February 17, 1917, he was a son of the late George T. Sr. and Helen Gertrude (White) Stradling. He was the husband of Jane E. (Brubaker) Stradling. They were married in San Diego, CA on December 13, 1942. They celebrated their 65th anniversary this past December.

He was a member of Grace Evangelical Congregational Church in Akron and had been very active in the former Evangelical United Brethren Church in Ephrata for over 25 years where he served as a Sunday School teacher and superintendent. He also served on the Pastor Parish and Finance Committees of Mt. Zion United Methodist Church of Akron.

George became a licensed funeral director before joining the Navy, graduating from Eckel's School of Embalming in 1938. He also helped reorganize the Cub Scouts in Akron in 1954. He was an avid hunter and golfer, and enjoyed painting, traveling, and playing scrabble and cards.

## Actor Paul Scofield, 86

Paul Scofield, the acclaimed British actor who created the indelible role of Sir Thomas More in Robert Bolt's play "A Man for All Seasons" and then repeated it on film in 1966 in an Oscar-winning performance, died Wednesday near his home in southern England. He was 86.

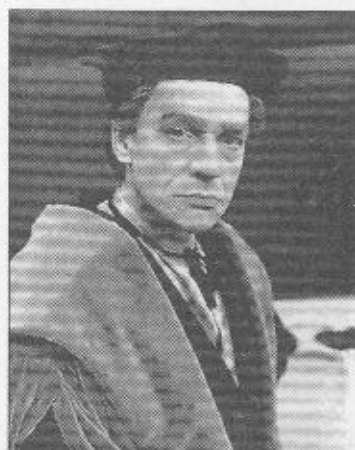
His death, at a hospital, was announced by his agent, Rosalind Chatto. He had leukemia.

Scofield was regarded by both critics and his peers as one of the greatest actors in the English-speaking world, one who brought freshness and power to Hamlet, King Lear and many other classic roles. But he might have been better known to the public if he had been less withdrawn. He seldom gave interviews and never appeared on television talk shows. A shy, reclusive man, he refused to accept the knighthood that was offered him in the 1960s.

Scofield was a wide-ranging actor who, thanks to his bearing and his height — he stood six-foot-two — could project power and authority in one role and an air of inscrutability in another.

Richard Eyre, who directed Scofield in the title role in Ibsen's "John Gabriel Borkman" in 1996, maintained that he was "not just the best there is, but the best there has ever been."

The role that brought Scofield international renown was

that of Sir Thomas More in "A Man for All Seasons," which opened in London in 1960. The mix of moral strength, intelligence, melancholy and wily grace he brought to Henry VIII's principled but ultimately disgraced Lord Chancellor won him a Tony Award when he made his Broadway debut in the role in 1961. That was followed by an Academy Award as best actor in the movie version of the play in 1966.

Despite his prodigious gifts and international fame, when the curtain fell, Scofield simply hopped the commuter train back to his family. He did not often mix socially with his fellow actors. At home, only 10

miles or so from his birthplace, were his wife, the former Joy Parker, an actress he married in 1943; a daughter, Sarah, and a son, Martin. They all survive him.

Scofield served as a director of the Royal Shakespeare Company from 1966 to 1968 and as an associate director of the National Theater from 1970 to 1972.

Paul Scofield was born David Scofield on Jan. 21, 1922 in the Sussex village of Hurstpierpoint.

In 1939 he enrolled at a school attached to the Croydon Repertory Theater and later moved on to the Mask School in London, which during World War II was evacuated from its headquarters in Westminster to Bideford, Devon. Scofield was exempt from military service because of deformed toes.

Scofield's big break came in 1944, when, at 22, he was asked to join one of the Britain's most important companies, the Birmingham Repertory Theater. The following year, a 20-year-old director and enfant terrible named Peter Brook arrived at Birmingham and a unique collaboration was struck. The partnership culminated in Scofield's memorable King Lear for the Royal Shakespeare Company in 1962. In 2004, members of the Royal Shakespeare Company, in an opinion poll, cited Scofield's 1962 portrayal of Lear as the greatest performance in a Shakespearean play.

Detectives seized \$3,450 in cash from a safe in an upstairs bedroom and took \$1,000 in cash from Monsanto.

Each man was charged with possession with intent to deliver heroin, criminal conspiracy, possession of drug paraphernalia and a Drug Free School Zone violation.

District Judge Cheryl Hartman set bail for Monsanto and Edwin Perez Perez at \$250,000 cash and at \$200,000 cash for Edwin Perez Rivera.

Now 58, Vulovic is said to be a possible inspiration for the opening scene of Salman Rushdie's novel "The Satanic

Verses," which describes the two protagonists surviving a high-altitude fall from an airliner blown up by terrorists.

In 1985, she was inducted into the Guinness Book of Records for "the highest fall survived without a parachute."

"She is one of the most famous Yugoslavs ever," said Cedomir Janjic, former head of the Yugoslav Air Force.
