### Country music superstar Eddy Arnold

NASHVILLE, Tenn. (AP) — Eddy Arnold, whose mellow baritone on songs like "Make the World Go Away" made him one of the most successful country singers in history, died Thursday morning, days short of his 90th birthday.

Arnold died at a care facility near Nashville, said Don Cusic, a professor at Belmont University and author of the biography "Eddy Arnold: I'll Hold You in My Heart." His wife of 66 years, Sally, died in March, and in the same month, Arnold fell outside his home, injuring his hip.

Arnold's vocals on songs like the 1965 "Make the World Go Away," a top 10 pop hit as well as a No. 1 country hit, made him one of the most successful country singers in history.

Folks yet sophisticated, he became a pioneer of "The Nashville Sound," also called "countrypolitan," a mixture of country and pop styles. His crossover success paved the way for later singers such as

## 7 more cops pulled from Philly streets

PHILADELPHIA — Seven more police officers were taken off street duty Thursday as investigators look into the videotaped police beating of three shooting suspects during a traffic stop.

Thirteen of the estimated 15 officers on hand during the Monday incident have been taken off the streets as investigators pore over the television news footage, Police Commissioner Charles Ramsey told a news conference Thursday.

The video shows officers kicking, punching and beating the men, who are all black. On his syndicated radio show Thursday, the Rev. Al Sharpton, compared it with the videotaped 1991 beating of black motorist Rodney King by a group of white Los Angeles police officers.

"I've not seen anything like that since Rodney King, and it's worse than Rodney King, and we cannot allow our community to be under siege," Sharpton said. "We've got to stop this nonsense in our community, acting like you got to be a certain level black to be treated within the law."

But Ramsey denied the beating was racially motivated, saying at least one officer involved, a sergeant, is black.

"I know everybody's trying to make this into a racial thing. I don't believe it is," Ramsey told The Associated Press later Thursday. "We just had a policeman murdered on Saturday ... and emotions are run-

ning high," he said about Sgt. Stephen Liczbinski, 39, who was shot while responding to a bank robbery.

On Monday, police stopped the suspects' car while investigating a triple shooting in the area. No weapons were found in the car or on the suspects, but officers said they had seen an occupant of the car shoot three people on a drug corner moments earlier, Ramsey has said.

The three suspects — Dwayne Dyches, Brian Hall and Pete Hopkins — were each charged with attempted murder and related counts in connection with the shooting, according to court records. Each was treated at a hospital and was being held Thursday in lieu of bail of \$100,000 or more, Ramsey said.

An attorney for the three, D. Scott Perrine, has said his clients had nothing to do with the triple shooting and that the beating was totally unjustified.

The commissioner pledged to send the department's preliminary investigation to prosecutors by next week. If prosecutors decline to file charges, he will deal with the officers involved internally, he said.

The Internal Affairs unit is still working to enhance the tape and identify all the officers in the footage, a department spokesman said.

"I sing a little country, I sing a little pop and I sing a little folk, and it all goes together," he said in 1970.

He was elected to the Country Music Hall of Fame in 1966. The following year he was the first person to receive the entertainer of the year award from the Country Music Association.

The reference book "Top Country Singles 1944-1993," by Joel Whitburn, ranked Arnold the No. 1 country singer in terms of overall success on the Billboard country charts.

Nicknamed "The Tennessee Plowboy," Arnold first gained notice with appearances on the Grand Ole Opry in the early 1940s. He debuted on the charts in 1945 with "Each Minute Seems a Million Years," and began his string of 28 No. 1 country hits with "What Is Life Without Love" in early 1947. His success helped make Nashville an important recording industry hub, according to Sony BMG Nashville, parent of his longtime label, RCA.

Other hits included "Cattle Call," "The Last Word in Lonesome Is Me," "Anytime," "Bouquet of Roses," "What's He Doing in My World?" "I Want to Go With You," "Somebody Like Me," "Lonely Again" and "Turn the World Around."

The late Dinah Shore once described his voice as like "warm butter and syrup being poured over wonderful butter-milk pancakes."

Arnold was born May 15, 1918, on a farm near Henderson, Tenn., the son of a sharecropper.

Arnold lived in Brentwood, a Nashville suburb. Survivors include a son, Richard Edward Arnold Jr., and daughter, Jo Ann Pollard, both of Brentwood.

# assault weapons ban

PHILADELPHIA — City and state officials called Thursday for Congress to reinstate a ban on assault weapons, delivering an impassioned plea the day before police were to bury an officer killed on duty by a high-powered rifle.

Mayor Michael Nutter said last week-end's "assassination" of Sgt. Stephen Liczbinski, who was shot at least five times by a Chinese SKS rifle while responding to a bank robbery, was "truly shocking."

"We all know that he did not stand a chance," said Nutter, speaking at a City Hall news conference. "It's a high-powered rifle that no one should have their hands on."

The comments came about 12 hours after a third suspect, Eric Floyd, was captured in an abandoned rowhouse in southwest Philadelphia. Floyd, 33, was caught following a five-day manhunt after police said an FBI agent received a tip.

Brought to police headquarters in Liczbinski's handcuffs, Floyd was charged with murder, robbery, conspiracy and related offenses. His girlfriend, Tonya Stephens, 37, was found with him and charged with obstructing justice, hindering apprehension and conspiracy.

Another bank robbery suspect, Levon Warner, 38, was arrested Sunday and charged with murder, robbery and conspiracy.

Suspect Howard Cain, 33, was shot to death by police Saturday during a postrobbery chase. An area mosque has refused a request to hold funeral services for Cain, a Muslim, because of his criminal conduct.

On Thursday, Nutter and Gov. Ed Rendell released a copy of a letter they sent to members of the state's congress-

sional delegation asking for the federal ban on assault weapons to be reinstated. A ban enacted in 1994 was not renewed after lapsing in 2004.

"Passing this legislation will go a long way to protecting those who put their lives on the line every day for us," Rendell and Nutter wrote. "There is no excuse to do otherwise."

Rep. Joe Sestak, D-Pa., who is co-sponsoring legislation to reinstate the ban, said police officers should not face the same types of weapons that U.S. soldiers come up

against in Iraq.

"I would like to see that we not only renew but strengthen the assault weapons ban that expired in 2004," Sestak said Thursday.

Rendell also criticized state lawmakers for refusing to pass what he called sensible gun-control measures. He mentioned attending a police memorial ceremony Monday in Harrisburg, where he said legislators honored officers' service with resolutions even as they refuse to make them safer by passing a law requiring that lost and stolen guns be reported.

"The hypocrisy is rampant," Rendell said.

Officials acknowledged the federal assault weapons ban would not have included the gun that killed Liczbinski, as it came to the U.S. in 1992.

But Police Commissioner Charles Ramsey bristled when told that some gun-rights organizations dispute whether the SKS rifle qualifies as an assault weapon.

The gun inflicts wounds so devastating that it should be considered one, Ramsey said angrily.

"Then add it to the frickin' list!" he said to sustained applause from officials and other police officers at the news conference.
