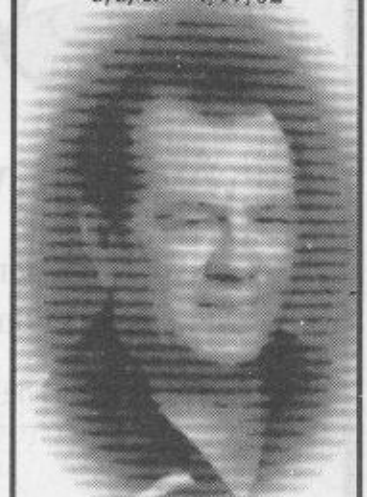

City man gets probation for assaults, theft at market

A 39-year-old Lancaster man was sentenced Wednesday to three years' probation for injuring two employees at a West Hempfield Township market during a botched retail theft.

Samuel L. Warren was confronted by a security guard and several employees of Redner's Market after they saw him conceal filet mignon steaks and jumbo lump crab meat, according to testimony.

Warren allegedly tussled with the employees, causing injuries to two of them that required treatment at an area hospital.

One man sustained a broken bone in his hand; the other sustained lacerations, according to testimony.

Warren pleaded guilty Wednesday to two counts of

simple assault, retail theft and providing false identification to police officers for the Oct. 20, 2007, incident at the Columbia Avenue store. Lancaster County Judge Joseph Madenspacher waived a background investigation and sentenced the defendant.

As part of the sentence, Madenspacher banned Warren from all Redner's locations. He also was ordered to pay \$783.93 in restitution.

Warren told the judge he was grabbed by the throat and reacted naturally by fighting with the men. He also claimed he never concealed the items.

Defense attorney Patricia Spotts interjected that Warren still wanted to plead guilty because he had no cash or other means of paying for the items.

"He had no cash on him," Spotts said. "He went in for the purpose of stealing."

Spotts told the judge a guilty plea was appropriate because her client would have little chance of being acquitted at a trial because he was penniless.

Madenspacher interrupted: "It would be extremely likely they would convict him."

Warren had stolen from the store before and employees were on the lookout for him, Assistant District Attorney Brian Chudzik argued. When Warren walked in that day, employees recognized him and paid close attention, Chudzik said.

Warren fought with the employees inside the store and in a vestibule by the front door, according to testimony.

"Don't come back here, Mr. Warren," Madenspacher said before closing the hearing Wednesday.

"I won't," Warren replied.

WASHINGTON (AP) — Edward Lorenz, the father of chaos theory, died at his home in Cambridge, Mass., Wednesday. He was 90.

He was a professor at the Massachusetts Institute of Technology when he came up with the scientific concept that small effects lead to big changes, something that was explained in an example known as the "butterfly effect."

He explained how something as tiny as a butterfly flapping its wings in Brazil changes the constantly moving atmosphere in ways that could later trigger tornadoes in Texas.

His discovery of "deterministic chaos" brought about "one of the most dramatic changes in mankind's view of nature since Sir Isaac Newton," said the committee that awarded Lorenz the 1991 Kyoto Prize for basic sciences. It was one of many awards that Lorenz

Rendell outlines terms of turnpike privatization bids

HARRISBURG — Toll increases on the Pennsylvania Turnpike would be capped and some of the turnpike commission's 2,240 employees are expected to eventually lose their jobs under a privatization plan released by the Rendell administration Wednesday.

Gov. Ed Rendell's aides said prospective private operators would have to submit bids near the end of April and the Legislature could approve a deal by mid-June. Officials were purposely keeping the precise timetable vague, but several legislative leaders said two months was not realistic.

If a lease of the turnpike is approved, a private firm will operate about 500 miles of the system for 75 years, and a con-

The operator would be allowed to increase tolls by 25 percent in January, and then each year by either 2.5 percent or the consumer price index, whichever is greater. 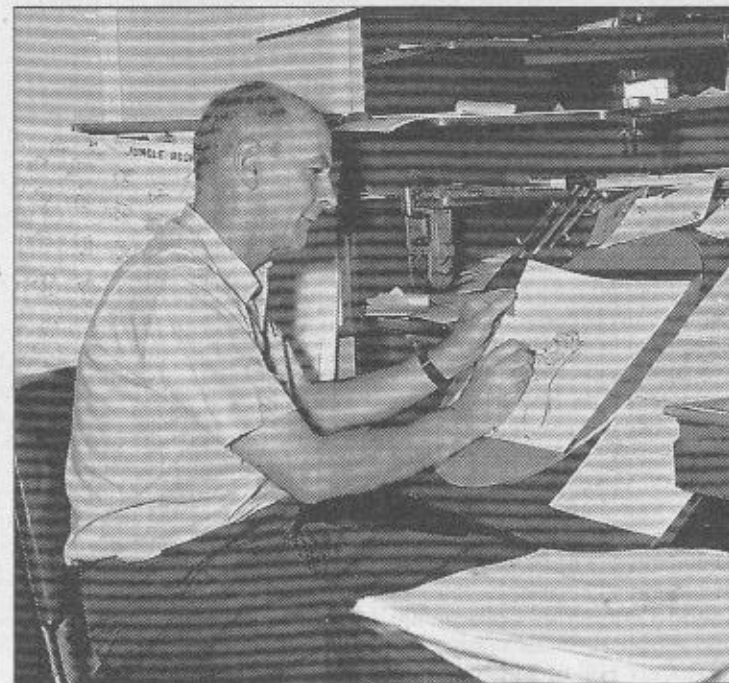

Veteran Disney animator Ollie Johnston dies at 95

LOS ANGELES (AP)—Ollie Johnston, the last of the "Nine Old Men" who animated "Snow White and the Seven Dwarfs," "Fantasia," "Bambi" and other classic Walt Disney films has died. He was 95.

Johnston died of natural causes Monday at a long-term care facility in Sequim, Wash., Walt Disney Studios Vice President Howard E. Green said Tuesday.

"Ollie was part of an amazing generation of artists, one of the real pioneers of our art, one of the major participants in the blossoming of animation into the art form we know today," Roy E. Disney, nephew of Walt Disney and director emeritus of the Walt Disney Co., said in a statement.

Walt Disney lightheartedly dubbed his team of crack animators his "Nine Old Men,"

borrowing the phrase from President Franklin D. Roosevelt's description of the U.S. Supreme Court's members, who had angered the president by quashing many of his New Deal programs.

Although most of Disney's men were in their 20s at the time, the name stuck with them for the rest of their lives.

Perhaps the two most accomplished of the nine were Johnston and his close friend Frank Thomas, who died in 2004 at age 92. The pair, who met as art students at Stanford University in the 1930s, were hired by Disney for \$17 a week at a time when he was expanding the studio to produce full-length feature films. Both worked on the first of those features, 1937's "Snow White and the Seven Dwarfs."

Johnston and Thomas and their families became next-door neighbors, and during their 45-minute drive to the Disney Studios each day, they would devise fresh ideas for work.

Johnston worked as an assistant animator on "Snow White," became an animation supervisor on "Fantasia" and "Bambi" and animator on "Pinocchio." He was especially proud of his work on "Bambi" and its classic scenes, including one depicting the heartbreaking death of Bambi's mother at the hands of a hunter.
