# France's last WWI veteran dies

National funeral planned

PARIS - France's last remaining veteran of World War I died Wednesday at age 110 after outliving 8.4 million Frenchmen who fought in what they called "la Grande Guerre."

Lazare Ponticelli, who was born in Italy but chose to fight for France and was a French citizen for most of the past century, died at his home in the Paris suburb of Kremlin-Bicetre, the national veterans' office said.

"It is to him and his generation that we owe in large part the peaceful and pacified Europe of today. It is up to us to be worthy of that," President Nicolas Sarkozy said in a statement.

France planned a national funeral ceremony Monday honoring Ponticelli and all the "poilus," an affectionate term meaning hairy or tough that the French use for their soldiers who fought in World War I.

1914-1918 conflict, The known at the time as the Great War or the "war to end all wars," tore Europe apart and killed millions. Only a handful of World War I veterans are still living, scattered from Australia to the United States and Europe. Germany's last WWI veteran died on New Year's Day.

Ponticelli was born Dec. 1897, in Bettola, a town in northern Italy.

To escape a tough childhood, Ponticelli trooped off alone at age 9 to the nearest railway station, 21 miles away in Piacenza, where he took a train to join his brothers in France, eventually becoming a French citizen, according to the veterans' office in Versailles.

In the French capital, he worked as a chimney sweep and then as a newspaper boy. When the war broke out, he was just 16, so he lied about his age to enlist, the president's statement said.

Ponticelli decided to fight barbed wire.

the war, which left 1.4 million for France, because it had taken him in.

"It was my way of saying Thank you," he said in a 2005 interview with the newspaper Le Monde.

Ponticelli joined the Foreign Legion during the war and served in the Argonne region of forest, rivers and lakes in northeast France, digging burial pits and trenches.

"At the beginning, we barely knew how to fight and had hardly any ammunition. Every time that one of us died, we fell silent and waited for our turn." he said in the 2005 interview.

He also recalled running into no man's land to save a wounded comrade stuck in The stretcher-bearers didn't dare go out. I couldn't bear it any longer," he said. When Italy entered the war in 1915, Ponticelli was called up

to fight with an Italian Alpine regiment. He tried to hide, but was found and sent to fight the Austrian army. He described moments of

fraternity with enemy Austrian soldiers.

"They gave us tobacco, and we gave them loaves of bread. No one was shooting any more. The headquarters found out and moved us to a tougher zone," he told Le Monde.

He described the joy in receiving letters from a milkmaid who "adopted" him when he was serving in Italy. He couldn't read at the time, so comrades read them to him, according to a biography by the Versailles veterans' office.

He returned to France in 1921. and he and his brothers started a company that made factory smokestacks. The company, Ponticelli Freres, grew into a manufacturer of specialized industrial equipment and is still in business.

Ponticelli became a French citizen in 1939, his nephew said.

His family was uncomfortable with the elaborate national funeral ceremony planned. Ponticelli agreed to one before his death, as long as it honored all the poilus and not just himself.

We are trying to keep this a bit personal. We didn't want all this ceremony," said his grand-nephew, Daniel Ponticelli.

He will be interred in a family burial plot in Paris.

HARRISBURG - A billiondollar-plus plan to help about 270,000 uninsured Pennsylvania adults get state-subsidized health coverage cleared a major hurdle Wednesday in the state House.

The 114-81 vote followed a nine-hour debate during which backers promoted the proposal as the next logical step to follow recent state laws that cover children and pay prescription costs for the elderly. The amendment still needs a final House vote and faces an uncertain fate in the Senate.

The sponsor, Rep. Todd Eachus, D-Luzerne, said it is nearly impossible to survive in modern society without health insurance.

"For House Democrats, access to affordable health care to working families is the key in all of our districts," he said after the vote.

Minority Leader Sam Smith, R-Jefferson, said he was concerned about the price tag, which is expected to reach \$1.1 billion by 2012-13.

"This program, fully implemented as it's proposed, is going to require a huge increase in revenues to properly run it and

# **Ex-Pa. trooper to plead** guilty to tipping off pimps

former Pennsylvania state trooper tipped off pimps who ran a child-prostitution ring in exchange for money and sex, federal prosecutors said Wednesday.

Kevin Judas Coleman Sr., 42, of Harrisburg was charged with interfering with a nationwide investigation into a ring that used women and teenagers as prostitutes. Prosecutors said he agreed to plead guilty.

Coleman was assigned to anti-prostitution patrols at the Gables Truck Stop along Interstate 81 near Harrisburg when pimps - many from Toledo, Ohio - were operating there, prosecutors said: He was accused of disclosing investigative details, cell phone wiretaps and police sweeps.

The federal investigation known as Precious Cargo led to the conviction of 14 pimps and two lead prostitutes, most of whom await sentencing.

The document charging Coleman with obstructing the

said a pimp let him have sex with a prostitute in exchange for arresting a competitor's prostitutes.

It also claimed that the trooper gave his work schedule to a pimp and his prostitutes so they knew when they could work without fear of arrest.

Coleman's actions were uncovered after investigators heard that someone in law enforcement was tipping off suspects, said Acting U.S. Attorney Martin Carlson in Harrisburg.

"It is always serious when law-enforcement officials who have a public trust violate that trust," Carlson said. "We owe an obligation to the public to serve the public's interest solely."

Coleman resigned from the force Jan. 28, after learning he was under investigation. The 14-year veteran's final salary was \$71,000. A phone message left for his attorney, Royce Morris, was not returned.

Carlson's office said Wednes-

HARRISBURG (AP) - A due administration of justice day that Coleman would be sent a summons, and his bail would be set once he appeared in court.

The federal indictment in December 2005 that broke up the prostitution ring described it as a "loose confederacy' where pimps worked together to avoid police and run their business. The women and girls were moved from state to state and "sold" between pimps.

At least nine were under 18 when they were forced into working as prostitutes, authorities said, and in one case a 12year-old girl was forced to engage in prostitution to pay for her grandfather's crack cocaine.

The pimps were indicted in Pennsylvania, New Jersey and Michigan, and the investigation was considered one of the largest coordinated efforts to break up child prostitution rings in the United States.

Investigators said they identified at least 125 women who worked as prostitutes for the ring in the Harrisburg area.

## **Police: Executive** beaten to death

READING (AP) - Reading police say a supermarket executive killed over the weekend was beaten to death.

The body of 55-year-old Garv W. Redner of Redner's Wholesale Markets was found Sunday morning outside a neighbor's house in Lower Heidelberg Township.

Redner had been in Ganly's Pub & Restaurant less than a quarter-mile from his house on the night before he was found dead. But authorities say they are not aware of any trouble at the establishment before he left.

State police say they are working around the clock to try to solve the killing. Lt. Thomas G. McDaniel says investigators are looking at a variety of possible motives.

The family has put up \$10,000 to raise to \$20,000 the reward offered for information leading to an arrest.
