Driver killed in Manor Twp.

A 31-year-old Lancaster County man was killed late Monday when his car slammed into the back of a milk truck in Manor Township, investigators said.

Jayson Boudier was pronounced dead at Lancaster General Hospital after the 11:15 p.m. crash in the 300 block of South Duke Street, investigators said.

Boudier was driving his Buick sedan north on South Duke Street, just south of Millersville, when he approached the milk truck, Manor Township Police Officer Charles Snyder said.

Manor Township Police said Tuesday evening that they are

trying to figure out how Boudier's Buick collided with the milk truck.

Police said they are investigating whether the truck was stopped or slowed when Boudier's Buick approached it.

Police haven't located any witnesses to the crash, they said.

The truck driver — John Frelak, 20, of Lancaster — was not injured. Frelak was driving for a company based in Lancaster, but investigators didn't say which one.

The posted speed limit at the site of the crash is 45 mph, and police are investigating whether speed was a factor.

After colliding with the truck, the Buick caught fire

with Boudier still inside, investigators said.

First responders pulled Boudier from his car and an ambulance drove him to Lancaster General Hospital.

It was unknown Tuesday whether Boudier died from injuries sustained in the crash or the fire. Results from an autopsy performed Tuesday morning were not available.

Both vehicles had to be towed from the scene, investigators said, and part of South Duke Street was closed for several hours after the crash.

Writers vote to end strike

LOS ANGELES (AP) — Striking Hollywood writers are going back to work. The Writers Guild of America said its members voted Tuesday to end their devastating, three-month strike that brought the entertainment industry to a standstill.

Writers will be back on the job today after voting in Beverly Hills and New York.

"At the end of the day, everybody won. It was a fair deal and one that the companies can live with, and it recognizes the large contribution that writers have made to the industry," Leslie Moonves, chief executive officer of CBS Corp., said.

Moonves was among the media executives who helped broker a deal after talks between the guild and the Alliance of Motion

Picture and Television Producers, which represents studios, collapsed in acrimony in December.

Residuals for TV shows and movies distributed online was the most contentious issue in the bitter dispute involving the 12,000-member union and the world's largest media companies and other producers.

Under a tentative contract approved Sunday by the union's board of directors, writers would get a maximum flat fee of about \$1,200 for streamed programs in the deal's first two years and then get 2 percent of a distributor's gross in year three.

"These advances now give us a foothold in the digital age," said Patric Verrone, president of the West Coast guild. "Rather than being shut out of the future

of content creation and delivery, writers will lead the way as television migrates to the Internet."

One winner in the vote was the Academy Awards, which can now be staged Feb. 24 without the threat of pickets or a boycott by actors that would have dulled the glamour of Hollywood's signature celebration.

The strike's end will allow many hit series to return this spring for what's left of the current season, airing anywhere from four to seven new episodes. Shows with marginal audience numbers may not return until fall or could be canceled.

The combined New York-Beverly Hills count was overwhelmingly in favor of ending the strike: 3,492 voted yes, with only 283 voting to stay off the job.

The bill, which passed the House on Monday and the Senate on Tuesday, aims to provide people with far greater information about the actions of their state and local governments. Gov. Ed Rendell's office said he will sign it.

The bill that emerged — after numerous revisions over 13 months — would force agencies to disclose all records beyond a list of exceptions, instead of the current law's narrow list of public records that are available.

It also would require agencies to prove records they do not want to release can be secret, where current law puts that legal burden on the public to prove why a record must be

A central office would set policies and deal with disputes about what should be released. Penalties would be stiffer for agencies that violate the law. And it would require state agencies to respond faster when people request records.

The revisions would improve access to 911 tapes and transcripts, mandate access to many of the General Assembly's records and expand the law to the "state-related" universities: Penn State, Pitt, Lincoln and Temple.

Electricity conservation plans OK'd

HARRISBURG (AP) — The state House of Representatives took a step Tuesday toward trying to deal with a looming spike in electricity bills, approving legislation intended to curb energy use and give ratepayers a choice of pricing plans.

The bill, a variation of a strategy Gov. Ed Rendell began advocating last year, is intended to help much of the state avert the price spikes that can happen when rate caps expire and customers are forced to pay the higher price of electricity demanded by wholesale markets.

Under the legislation, which passed 152-45 and now heads to

the Senate, utilities must develop plans to conserve electricity and install "smart meters" in all homes and businesses within 10 years.

Advocates also hope that conserving electricity will be cheaper than building new power plants and transmission lines and help avoid the pollutants that electricity generating plants may create.

"What we do know is that this is not just mandating utilities," said J. Michael Love, who heads the Energy Association of Pennsylvania, which lobbies for the state's electric utilities. "This is mandating consumers to dra-

matically alter, and I don't mean slightly, I mean dramatically alter their electricity usage."

With many states moving in the same direction, the legislation would help Pennsylvania catch up, supporters said.

"It will make Pennsylvania a national leader on energy conservation," said John Hanger, a clean-energy advocate and former state utility commissioner. "Right now, we're at the back of the energy conservation bus, doing very little."

However, critics say many ratepayers will get no benefit from smart meters — but will have to pay for them anyway.
