Media glare sheds little light on private man

NEW YORK - Close vour eves and think of Heath Ledger. OK, now try to get beyond those chiseled good looks. What probably pops to mind isn't a grinning red-carpet photo but one of an urban dad, carrying a toddler on his shoulders or pushing a stroller down a city street - a tableau captured by countless celebrity magazines.

And maybe that image one that in a sense made him more like us, but also kept us at a distance - is one reason why the loss of this actor with a pensive look and a blazing talent is evoking genuine sadness and less of the usual prurient fascination with untimely Hollywood deaths.

News of Ledger's death at age 28 had broken less than an hour before Nicole LaChappelle, a 40-year-old school administrator in Easthampton, Mass., got home from work Tuesday. Yet she had an immediate e-mail and a phone call, too, from shocked friends.

"It hit me as stunningly sad, something different from the typical celebrity who had maybe struggled with substances," said LaChapelle, who admired "Brokeback Mountain" but lyn neighborhood, not the

And his work was so widely admired in part for the challenging choices he made, in a career that could have easily just cashed in on his looks and charisma. Rather, he chose difficult films like "Monster's Ball," in which he played a prison guard, and of course, "Brokeback Mountain."

"He captured all the colors of that role, of a repressed man about to implode," said Maltin. "It's such a shock and such a loss. I didn't really know him, but I feel a terrible loss."

Some wrote Wednesday of Ledger's affinity for playing tortured souls, and speculated that perhaps these roles mirrored anguish in Ledger's own soul. But New York Times critic A.O. Scott cautioned against that. "Those roles should be seen less as expressions of some imagined inner torment than as evidence of resourcefulness, creative restlessness

and wit," he wrote. And celebrity editor Bonnie Fuller, in a blog entry titled "Why, Why, Why?" on the Huffington Post Web site,

even looked to literature for answers, and to the tortured character in Emily Bronte's "Wuthering Heights" that Ledger was named for: Heathcliff.

In the immediate aftermath of Ledger's death, outside the SoHo apartment where his body was found, there was one particularly jarring sight. There wasn't much to show on TV, or to photograph, and so viewers were treated to footage of paparazzi snapping shots of four or five lonely bouquets of flowers.

No, Ledger was not Princess Diana, whose death drew football fields of bouquets. But neither was he Anna Nicole Smith, whose drug-fueled death drew fascination and Web hits but little shock and little public grief. Ledger's fans, and many who didn't quite know they were fans, were grieving this week for a man of seemingly few words but a whole lot of mystery, talent and potential.

"With her death, the Eyak language becomes extinct," Krauss said. In all, he said, nearly 20 native Alaskan languages are at risk of the same fate. He called them "the intellectual heritage of this part of the world. It is unique to us, and if we lose them, we lose what is unique to Alaska."

The Eyak ancestral homeland runs along 300 miles of the Gulf of Alaska from Prince William Sound in south-central Alaska eastward to the town of Yakutat. Jones was born in Cordova in 1918 and grew up on Eyak Lake, where her familv had a homestead.

DEAR READER: Age spots are one unfortunate development that affects many people as they age. The lesions most often appear on the backs of hands, faces and arms. They are generally harmless unless they change markedly in ap-

Prescription bleaching creams containing hydroquinone can be prescribed. These creams can be used alone or in conjunction with retinoids and a mild steroid that can work toward fading the lesions. This treatment may take several months before any positive effects are noticed.

Dermatologists can use a freezing method known as cryotherapy that applies liquid nitrogen or other freezing agents to the spots. The procedure can pose a slight risk of permanent scarring or discoloration

Another procedure known as dermabrasion can sand down the surface layer of the skin with a rapidly rotating brush. Temporary redness and scabbing can occur following dermabrasion.

> Laser therapy also will fade age spots. Depending on the type of procedure the physician uses, it may take several return visits.

> Dermabrasion, chemical peels and laser therapy may not be covered by insurance. They often are considered cosmetic procedures and therefore not medically necessary. Be sure to check with your insurance company to see what procedures are covered. If none, then ask about setting up a payment plan with the physician

> Most actinic keratoses can be prevented by taking proper care of your skin, such as using sunblock and proper clothing when going outside. It is best to have a dermatologist look at all new skin lesions to ensure they are not cancerous before deciding on treatment.

> While all procedures sound distressing, they are safe if performed by qualified professionals. I suggest you be examined by a dermatologist, who can further advise you on which procedure, if any, might be appropriate.
